Brief presentation of the exhibition:

The Salon Art Capital is one of the major art events in Paris, France. It is considered one of the most renowned art salons and brings together a wide variety of artists and contemporary artworks.

The Salon Art Capital was created in 2006 following the merger of four historic salons: the Salon des Indépendants, the Salon Comparaisons, the Salon des Artistes Français, and the Salon du Dessin et de la Peinture à l'eau. It takes place every year at the Grand Palais, an iconic and prestigious venue in Paris.

This prestigious art event provides a platform for emerging and established artists to exhibit their works and connect with a diverse audience, from art enthusiasts to collectors and industry professionals. The Salon Art Capital showcases a variety of artistic disciplines, including painting, sculpture, photography, printmaking, ceramics, and more.

Participating in this event allows artists of the Déstructuralisme Figuratif to showcase their works to the salon's audience, thereby strengthening their recognition and reputation.

Being selected to be part of this prestigious exhibition is a recognition of the quality and relevance of the Déstructuralisme Figuratif, further enhancing the credibility and legitimacy of the participating artists.

The Concept of Déstructuralisme Figuratif:

Déstructuralisme Figuratif is an artistic movement characterized by an approach that challenges traditional conventions of representation, exploring unconventional forms, compositions, and perspectives. Déstructuralisme Figuratif aims to deconstruct traditional visual forms and structures while maintaining a certain recognizable or figurative representation. This can be manifested through distortions, fragmentations, or juxtapositions of visual elements, creating tension between form and representation. This artistic approach allows for the exploration of new expressive possibilities and encourages reflection on the perception and interpretation of art.

PARTICIPATION FEE:

These fees apply to the artists selected to participate in the exhibition.

The participation fees must be submitted along with the application dossier.

For artists who are not selected, the participation fees will be refunded after the selection process.

Foreign: All payments from foreign countries must be made in euros. For countries outside the SEPA zone, please add an additional €20 for bank fees.

In the case of non-admission to the Show, for exhibition fees paid:

- By check*: the cheque of the exhibition package of 450 € will be sent back to you with the mail after the selection.
- By transfer: the exhibition fee of 450 € will be refunded by cheque* or transfer.

REGISTRATION

You can make your registration request by email, on our website or by post.

Only complete applications will be selected by the selection board, which will decide on the admission and the location you will have.

Your application must be sent before Monday, 30 September 2024 included.

The Artist can register

1. By mail / Wetransfer:

- The registration form must be completed in capital letters and duly dated and signed.
- 1 to 4 images of the works proposed for good quality selection (resolution 300 dpi.)

2. By mail:

- The registration form must be completed in capital letters and duly dated and signed.
- 1 to 4 images * of your good quality works (resolution of 300 dpi) on USB key (no CD), the name/surname or pseudonym on must be mentioned on the key. Attach 1 envelope labelled with the name and address of the address, franked according to the weight of the file.

PRESENTATION OF ARTWORKS

The title, size, technique, year and name of the artist must be specified on a label, pasted or hung on the back of the works.

1. Painting:

Optional frame or simple frame or American case with adapted and effective hanging system.

2. Artwork on paper / Engraving and printmaking:

Simple framing preferably under Plexiglas with adapted and effective hanging system.

3. Photography / Digital Art:

Printing on paper: Simple framing preferably under Plexiglass.

Printing on Dibond, Aluminium, Plexiglass: to avoid the risk of damage on all four sides of artworks, framing is strongly recommended with an American case with an adapted and effective hanging system.

4. Sculpture:

Fireproof bases or M1 wood and showcases are to be provided by the artist. All works must be fixed securely on their base. Base colors allowed: White and grey.

The artworks can be dissociated during the installation.

Any sculptural work over 50 kg must be placed on a pallet so that it can be moved easily.

DEPOSIT OF ARTWORKS

The return shipping costs and insurance are the responsibility of the artist.

INSTALLATION AND DISMANTLING OF ARTWORKS

The installation and dismantling of the artworks will be carried out by the team of Association DF, but all artists who are available and willing to lend a hand are welcome to participate.

OPENING RECEPTION

Public opening reception on Thursday, February 13th, 2025, from 11 a.m. to 10 p.m.

PACKAGING

The packaging of each artwork should be simple and sturdy. It will be reused for the return shipment of the artworks if it remains undamaged. Here's a reference model:

To avoid any issues when sending your artworks via La Poste (French postal service), please note that it is preferable not to use wooden boxes or wooden materials, as they will not be accepted by the postal service.

SALE

The artworks presented are free for sale. No price will be displayed on the exhibited work, but the price list will be available at the reception of the exhibition on a specific document made by the association DF. The association will facilitate contact and transaction with the prospective buyer.

In case of sale:

Payment by cheque - The cheque will be issued in the artist's name. Association DF takes no commission.

Card payment - The DF Association uses a SumUp card reader to facilitate credit card transactions. In this case, the association DF will charge a symbolic commission of 5% on sale. The transaction fee of Sumup will be charged to the artist.

Refund no later than one week after the exhibition.

Please note that as long as the payment does not go through the DF Association account, we do not charge any commission.

The Association will not take any commission on sales and gives artists the freedom to support the association with a donation that will be the subject of a receipt.

The identification of the artist with the La Maison Des Artistes is the responsibility of each artist, as the declaration to his Tax Center in BNC for a number of Siret.

The artist will provide the invoice and certificate of authenticity for the buyer (by email or post).

INSURANCE

The association will take care of the liability insurance that is incumbent upon it.

The exhibition space is guarded during the event's opening hours.

Each exhibitor may, if they wish, take out their own insurance.

Association DF disclaims any responsibility in case of theft or damage.

ARTWORKS WITHDRAWAL

Withdraw the artwork on site: Sunday, February 16th from 6:30 p.m. to 8 p.m.

No exhibited work can be removed before the end of the Show

The team of the association DF will be present during this day to welcome the artist.

The artworks may be removed either by the artist or by an intermediary upon presentation of a deposit/ withdrawal voucher or a removal voucher from the carrier designated by the artist.

No work may be stored at the exhibition site after this date.

Return of Artworks via Carrier:

The artist is responsible for the transportation costs.

The artist must provide Association DF with information about the chosen carrier (Colissimo, DHL, FedEx, UPS, etc.) along with the shipment tracking number.

The team from Association DF will repack the artworks.

ANNULATION D'EXPOSITION

In case of force majeure, resulting in the cancellation of the Show, Association DF reserves the right to charge 35% of the exhibition fee, to cover the costs already incurred.

DATA PROTECTION

In accordance with the law « Data Protection Act », the artist can exercise a right of access to the data concerning him and have them rectified or deleted by contacting the association DF at the coordinates indicated above.

REPRODUCTION RIGHTS

The artist agrees to publish in the catalogue and communication media of the Salon 2025, the data provided as well as the reproduction and/ or dissemination of the works selected by the jury of the Association DF. The artist waives copyright and authorizes the association DF to keep the data provided for its archives and any other communication subsequent to Salon 2025.
